NOTICE OF APPLICATION FOR MARKET OPERATOR LICENCE TO OPERATE AN ELECTRICITY MARKET

In terms of section 11 of the Electricity Regulation Act 4 of 2006, the National Transmission Company South Africa SOC Ltd (NTCSA), hereby notifies all residents of South Africa that a Market Operator Licence application has been lodged with the National Energy Regulator of South Africa (NERSA).

The purpose of the Market Operator Licence is to authorise the NTCSA to operate and administer the electricity market platform in accordance with the provisions of the Electricity Regulation Act, applicable regulations, and market rules.

Subject to the approval of the Energy Regulator, this Market Operator must:

- provide for a transparent, non-discriminatory trading platform for power market participants to trade; and
- develop market code and rules, including qualifying criteria for power market participants.
